SERRANO vs. COOPER, Harrisburg.

And now, with June 12, 1881, on motion of T. F. Fox, Esq., Attorney for plaintiff, the Court ordered and directed that the issues in this case, to be tried in the Court of Common Pleas of Allegheny county, according to the Act of Assembly, in such cases as provided, as per certificate of P. C. Seligson, Esq., Prothonotary of the Supreme Court, for the middle district.
