Extract from a letter from Bro. Mackay, to the Corresponding Secretary, Jan. 5.

I close a few moments every month to write to you some incidents, thinking you are always anxious to hear of our doings on this side of the great waters. Mrs. M. and myself are in good health and spirits. The cause of religion is still on the advance. Now for my first visit to San Jose mission, the last mission, I believe, established by the Mexican government. It is styled the frontier mission, established some sixty or seventy years ago. It is directly north of this some fifteen miles, over a beautiful plain, which in a very few years, will be laid out in well-regulated farms. I stopped with Mr. Beard, one of the principal proprietors of the place. His wife is a member of the Presbyterian Church, and a very clever, pious lady. They received and treated me most kindly. On Sabbath morning a large room was prepared for preaching, and by 11 o'clock it was crowded full of attentive and apparently serious persons. Little did the oldest think, seventy years ago, when building the church and adjoining buildings, that one day a Protestant sermon, with the holy precincts, strange things come to pass in this world. The old adobe church, covered with tiles, bears the marks of old gray-headed time. The grate in front of the church, where they place their pious dead, I passed through it, and observed a rough coffin standing against the building. Upon inquiry, I was informed that the deceased was a Frenchman, first put into this coffin, and then thrown into the grave, without any corpse. Passing on, my eye fell upon human bones lying upon the surface of the ground. I felt shocked at the sight, and expressed my regret, but my informant said, "A merchant of that place, formerly of Pennsylvania, an old acquaintance of Mrs. M., said, 'Sir, I have seen enough of persons during the last few months, that I have seen the entire surface two feet deep; they dig them up to give place for new subjects.'" Said he, "Come up a little further, you will have still another sight." I followed, and soon we stood upon the skulls and unbroken bones of scores. These are the bones of heretics or unworthy members of the Church. The country east of the mission is mountainous; was a plain stretching out for miles and miles to San Francisco Bay. There is an excellent connection with the mission; the pears are getting ripe, and are the most delicious I ever tasted. Grapes were coloring, peaches not ripe, but looked a good deal better than I have in mind of home. Upon the whole I was pleased with the mission. I trust the Lord will bless our feeble efforts to do them good.
