THE WHO PIONEER.

The Whig Coalition Government, after an arduous session, yesterday, made choice of a County Ticket for the support of the party at the ensuing election. Some of the nominations were made by acclamation, and others were contested valiantly, the principal struggle being upon the nominations for Prosecuting Attorney and Canal Commissioners.

For President of the Judicial District, Mr. D. C. Miller, of the ballot made choice of Mr. Morris Hammon. The name of this gentleman is familiar to the whole country. He stands in the first rank among the members of the Pittsburgh bat; both as an eloquent and effective advocate and as an accomplished and profound orator. He goes before the people with an unassisted reputation, and will receive, as he will deserve, the testimonial of their approval at the next election.

For Senator, the Committee, with great unanimity, presented the name of Dr. James Gazon. Dr. C. has already served one term in that capacity, and this endorsement from his party friends was eminently due to him. Allegheny never had a more faithful representative at Washington than he, nor one possessing a higher degree of honor and honesty. Attentive to the claims of his constituents, and judiciously watching over the interests of the State, he has deserved general commendation. Of his triumphant election there can be no doubt.
