HOUSE.—The Bill introduced by Mr. J. C. Breckinridge, of Kentucky, for the admission of Indiana into the several States was taken up and after long debate passed, yes 81, nays 75.

The House granted ten hours of debate to be applied to the consideration of a bill to regulate railroads.

SENATE.—The Senate, after unimportant debate, took up the House bill.

Mr. Thomas, of Ky., made a strong speech against the bill, characterizing it as a premium to foreign paupers, and those too lazy to work.

New York, April 10.—The ship Powhatan, supposed to have been lost, was wrecked on Sunday, near Little Egg Harbor. All on board perished. The bodies were washed ashore.

The schooner Manhattan, of Bangor, Maine, was also wrecked, and there was only one survivor.
