THE MAINE LAW IN NEW YORE .- After a long ad vigorous struggle, which has lasted for years, the friends of a stringent prohibitory liquor law have triumphed in New York. The bill has passed both Houses, and the Governor has signed it. Whatever good can be accom-plished by such a measure, New York will have the benefit of it.

The law is of a very stringent character. It goes into effect on the fifth of July, giving an opportunity for all thirsty patriots to take a reg-ular blow-out on the fourth. After the fourth, no Rum, Brandy, Gin, Whiskey, Wine, Beer, or other intoxicating liquor can be legally sold, or given quay, except by persons specially authoriz-ed to sell for mechanical, medical, or sacramened to sell for mechanical, moutual, or saviance-tal purposes. Any citizen of good moral char-acter, being an elector of the town or city in which he proposes to sell, and not being a ped-dler, nor interested in any tavern, grocery, fruit store, confectionery, or other place of enter-

talmment, nor employed therein, nor captain, agent, clerk or other person employed on a res-sel or steamboat, may, from and after the lat of takenst, por employed intered, nor exployed in a result to be be definitions of the design of the des May next, keep and sell liquors for mechanical, chemical, or medicinal purposes, or pure wine for macramental use, provided he shall, within
