Serious Riot and Homicide at Larimer's

We are pleased to report a riot and homicide which took place at Larimer's saloon, on the corner of Broadway and Larimer street, on Saturday evening last.

It appears that a difficulty occurred about eight o'clock on Saturday evening between a young man named Arnold, and a man named Elijah Owen, in which Arnold was wounded and badly beaten at the store of Mr. Larimer.

It was in company with him a dozen others who were watching the Pennsylvania Railroad. We do not learn the origin of the difficulty, but it seems likely to grow into a general riot when the contest of the evening.

Between twelve and one o'clock on Sunday morning, the crowd returned to the house and another assault was made on the saloon.

Mr. Arnold was shot in the chest and died of his wounds. The saloon was destroyed by fire.
