Funeral of John Brown took place at North City on Thursday, at 10 o'clock. The body was borne by six neighbors from his own home to the rock near by, under the shadow of which he had directed to be laid. The coffin had been previously placed in front of his door-step, where his neighbors came to crowds to take a last look. The face was hardly changed. He was dressed in his usual attire, and was lying in state in the parlour of the house, his favorite hymn, "How Firm a Foundation," being sung by the Rev. J. H. O'Connell, and two others of that city, his children being present. Remains were taken care of by Mr. McKinnon, of Philadelphia, and the family and friends. At the grave Mr. Young, quoted Paul's words: "I have fought the good fight," etc., and pronounced a benediction. It was deeply touching to see the three widows leading on the arms of strangers and relatives. The crowd slowly and reluctantly left the ground, and the martyr is left in his grave among the hills.

California Wool.—That few, even of those engaged in the trade, know the extent and rapid increase in the imports of California Wool. The total amount received from New York and England since the commencement of the year has been as follows:

A New Style Hat.—A new hat, half dollars has been put out by the United States Mint in Philadelphia, to be submitted to government for its approval. The new coin, which is the same diameter as that now in circulation, is much thicker than the rim in consequence of the deeper striking of the die, and hence much more durable. On one side is a medalion portrait of Washington, with the head wreathed with laurel, the word LIBERTY upon a scroll below, and at the bottom the date 1789; and around the whole the words United States of America, in plain well defined letters. On the reverse side, a wreath of grain encloses the word DOLLAR, in the same beautiful letters.

The assembly of Modena having in its last sitting decreed that the domain of Castelvetro, which is national property, should be placed on a gift to Donator Farini, the latter immediately returned thanks in a letter, in which, however, he respectfully declined to accept the gift. Some deputies waited upon Mr. Farini, in order to persuade him to accept, but he replied, "Contentment, do not deprive us of the glory of living poor. This distinguished man has created a great sensation at Modena.

The People's Meeting held at Gettysburg on Wednesday evening did not elect a delegate to the Harpersburg Convention, but recommended the call of a county delegate convention by the Republican Committee. The meeting also adopted endorsing Senator Cameron and recommending Hon. John Corwade for Governor of the District.
