RESOURCES OF OUR NORTHWESTERN COUNTIES.

That portion of Western Pennsylvania which lies between the Ohio river on the South and beyond the Allegheny River and the Ohio State line is a district of the beauties and resources of which few people who have not carefully examined them can form a proper conception. We propose to give in a very brief way, the result of our own observations, made a few days ago in an excursion through the valley of the Shenango to Meadville, and of facts gathered from the statements of many of very intelligent gentlemen who reside in various parts of the State. It is the broad and beautiful valley of the Shenango that we shall more particularly speak.

The Beaver River, which enters the Ohio at New Castle, some twenty miles below, has its course through the country, embraced in the counties of Beaver, Lawrence, Mercer, Butler, and the southern part of Venango County. Its principal resources are the coal fields, which lie mostly southward in the town of Butler, the Neshannock, which, with the Monongahela, leaves the latter only a short branch to Western New York and Buffalo.
