GOVERNMENT WITHOUT CONSENT. That England has shamefully mismanaged her affairs, for many centuries, is a fact decided by all men who are so measured by theologic egotism that they consider all historic problems from the standpoint of a creed. This number of incidents most enlightening and a good many more. All these, to borrow a phrase from President Johnson's recent message, believe Ireland is entitled to be "well and humanly governed," and that this is what England has done for her.

Some of the most able leaders have been convicted, sentenced to death, and executed. The popular mind has been formed in the belief that in the blowing up with powder of a prison which Fenians were incarcerated in, a conspiracy to assassinate the Queen, and in projected federal services, the Fenians are the strength of their determination to exact retributive justice.

These are the legitimate fruits of that "well and humanly governing" which the Conservatives are anxious to introduce into the Southern States. There was a time when that sort of government laid on the shoulders of the people a burden which was little less than that which was borne with little vindictive; but that was a time of ignorance, when men did not understand their rights, and when they did not dare maintain them. Happily for all but tyrants, that period has passed, and now we are to see the Fenians, as they are called, disappearing from others. All efforts by Conservatives, to restore it, will be in vain.

THE CONSERVATIVE PLATFORM. Political parties are always distinguished by their general ideas and tendencies, rather than by the specific measures, having more or less of a tendency for which they were devised, except through the regular progress of events and of consequence.
