
PITTSBURGH TURNBEZRICK.

Biennial Celebration --- Procession --- Athletic Contests and Fete at Haltnorth's Garden.

We take the following interesting account of the great German Festival, in which so many of our Pittsburgh Germans partici-Dated, from the Cleveland Leader

A more propitious morning for an out-of-door celebration than that o: Monday could scarcely be desired. Not a cloud appeared in the sky and the recent rains left the roads free from dust and delightfully cool. roads free from dust and delighting to a Early in the morning the Turners began to appear on the streets, coming from every side, and all hurrying to the place from street, was to commence. whence the march was to commence. Their linen costumes and red badges made them quite conspicuous, while their jolly faces, well developed forms and hearty appearance made them a very pleasant sight to look upon. Soon after eight o'clock those who had assembled at the Hall, on Ohio street, marched in line, headed by a band and carrying various banners, to the Sænger Hall, on Superior street, where they were reinforced by the different societies who were to take part in the exercises of the day. Shortly before nine o'clock everything

was in readiness, and the procession began its march to Haltnorth's Garden in the following order:



In this order the long and gay procession marched, with banners flying and music playing, through Superior street to Ontario, thence to Kinsman, and up Kinsman until the footmen were obliged to take to the sidewalk on account of the mud. Then those in conveyances gradually began to pass those walking; and upon reaching Halfnorth's Garden, they who started at the foot of the procession were at the head. ...The ladies alighted first, and entering the gate formed a double first, and entering the gate formed a double line of beauty, all dressed in white muslin dresses, modestly high in the ueck, and wearing pink sashes. Through this white hedged avenue marched the gentlemen, gallantly doffiing their hats as they, caught sight of the welcoming smiles. When the last company had en-tered the garden a halt was ordered, and travel. the men in their turn opened ranks, and the ladies, joining hands, passed through. It was then half past ten o'clock, and the sun had become: quite warm. Prepara-tions were innucliately made for the sun had become quite warm. A portable horizontal bar was first brought, and firmly placed near the stand in the east end of the garden. The anxious throng crowded so closely around the contestants that it was found necessary to draft a pose of Turners to keep a reasonable space clear. C. Conrad, instructor of the Pittsburgh Turnverein, and gymnastic director of the occasion, then summoned those who desired to consummoned those who desired to conthen tend for the society's prizes. Fourteen young men, dressed coolly, and perfect specimens of symmetrical propor-tion, presented themselves and entered

their names. Six were from Cleveland their names. Six were from Cleveland, four from Pittsburgh, three from Johns-town and one from Wheeling. They were arranged in line, and as their names were called stepped under the bar, which was elevated some seven feet. -For the first time since the Broad Top Rallroad has been in existence, has one of the trestles given way while cars were passing over; but it was left until Friday morning last for such an accident to occur. 
