STATE LEGISLATION.

The Senate, on Tuesday, passed a bill directing the State Treasurer to repay Samuel Allison, late Treasurer of Pittsburgh, the amount overpaid by him to the State.

Also, a bill allowing the Treasurer of Pittsburgh, for the collection of mercantile licenses, the same fees as those now allowed the Treasurer of Allegheny county.

A bill is pending in the Senate empowering the city of Allegheny to issue bonds to the amount of \$100,000, payable in twenty years, at not exceeding seven per cent. interest, and exempt from State and municipal taxes, to be designated "Water Bonds," with a proviso that five per cent. of the bonds issued in any one year shall be set apart out of the proceeds of water rents, plus the interest, for the redemption of said bonds.

Also, an act concerning the Reserve township school district, all rights of school property between said Township and the district composed of the Township ward of the city of Allegheny, as settled and paid for in like manner as is provided by act of 11th April, 1892.

Also, an act providing for the sale of liquor to be sold in the township of Finley, in the county of Allegheny.

The Senate has passed an act providing that at the next election (after the passage of this act) in the township of Robinson and Scott, in the county of Allegheny, and tri-annually thereafter, the qualified voters of said districts respectively shall elect three persons in each, who shall be "license commissioners" for those districts, and shall hold office for three years, receiving no compensation, and any vacancy occurring shall be filled by the Court of Common Pleas. This license board is required to examine all applications for license to sell liquors, or to keep eating houses, in either of said townships, which may be made to the county license board, under act of March 21st, 1891, and no license shall be granted by the county board, to take effect in Robinson townships, until it has been endorsed and approved by a majority of the license commissioners of the proper township. This act has also passed the House.

The Senate has also passed an act authorizing the School Directors of McClelland township, to borrow, for the purpose of building school house, or school house, and to issue bonds for the purpose of not less than one hundred dollars each. The directors are also authorized to levy a tax annually from the passage of the act, not exceeding one per cent. ad valorem on the appraised valuation of property.

A bill has been reported in the House authorizing the authorities of Allegheny to borrow not exceeding fifteen hundred dollars, to be appropriated to repaying the present indebtedness of the township, in sums of not less than two hundred dollars, the interest thereon not to exceed eight per centum, payable annually, or semi-annually, in sums of not less than ten dollars, as determined by the Board of Finance or Council of that borough, and said bonds shall be payable only at the residence of the borough treasurer by the holder thereof, or his attorney in fact.

The House, on Tuesday, passed a bill for the relief of J. M. Egan, Sheriff of Pittsburgh. He contracted to furnish bread for the prisoners in the Allegheny County Jail during the term of Sheriff Woods' death, and at the time of his (Woods') death he was indebted to the county for the amount of \$1,500, in pursuance of contract to the amount of \$1,500, and insufficient to pay more than a portion of said sum, therefore it is proposed by the act that the Controller of Allegheny county be required to examine the claim of J. M. Egan against the estate of Sheriff Woods, ascertain the balance due him with interest, after receiving his proper dividend from said estate, and certify the balance so found to the County Commissioners, who shall direct the sum to be paid after claims against the county are paid.

An act is pending in the House to legalize the transactions of the Local Committee of East Deer township, Allegheny county, in agreeing to pay to each elector (to all the quota of the district under the draft) the sum of four hundred and fifty dollars, being one hundred and fifty dollars more to each recruit than authorized by law.

On the Senate calendar is an act providing "that it shall be unlawful for any person, company or corporation, owning, managing, or controlling any oil refinery, soda works, manure factory or other manufactory, slaughter house, cess pool or privy, in the counties of Armstrong, oil, tar, blood or other refinery, or any other manufactory, slaughter house, cess pool or privy, to discharge into the Allegheny river, or any of its tributaries, under a penalty of one hundred dollars for each such discharge, and every day the offense is committed, and to be remitted or suffered, said penalty shall be recovered by suit before any justice of the peace, or half to go to the school district wherein such refinery, factory, cess pool, house, cess pool or privy is located, and the other half to the informer. Any person violating this act shall, in addition to the penalty therein provided, be deemed guilty of committing and maintaining a common nuisance, and may be indicted, and upon conviction shall be punished by a fine not to exceed one hundred dollars for the first offense, and not less than one hundred dollars for each subsequent offense; and it is hereby made the duty of constables to return all violators of this act."

An act has passed the Senate incorporating the "Allegheny County Monumental Association." The incorporators mentioned are Mrs. Sam'l McKee, Mrs. Jno. Wall, Mrs. R. Robinson, Mrs. B. Preston, Mrs. E. Sellers, Mrs. R. D. Thompson, Mrs. Alexander Chambers, Mrs. M. O'Leary, Mrs. Jno. Barton, Mrs. A. L. Pearson, Mrs. Dr. M. Cote, Mrs. H. F. Mann, Mrs. Mary Howard, Mrs. Miss Linn Presley, Miss Madie Fowler, Mrs. C. C. Scaife, Mrs. Leonard S. Scott and Sam'l McCord. It is provided that the annual dues of each member of the association shall not exceed one dollar, and that the annual dues of the corporation shall not exceed one dollar, and that the object of said association shall be the erection of a suitable monument, within the county of Allegheny, to the memory of the soldiers from said county who fell in the late rebellion, from contributions also made or to be made for that purpose raised for the purpose of said corporation.

An act was passed by the Senate on Tuesday, authorizing Right Reverend Michael Donohoe, Catholic Bishop of Pittsburgh, to sell, at public or private

sale, at his discretion, a piece of land in Millin township, containing 85 and 1/2 acres, a piece of land heretofore sold by George Almyer to Thomas Foster, the proceeds arising from such sale to be applied first to the payment of expenses incurred and debts of the German Roman Catholic School of Millin, to be paid any balance to be used by Bishop Donohoe for the equal benefit of St. Peter's Roman Catholic Church of McKeesport and St. Agnes Roman Catholic Church of Millin township.

The act to provide for the appointment of an inspector of illuminating gas and gas meters, &c., in the county of Allegheny, passed by the House on Tuesday, is a transcript of the Philadelphia bill offered and defeated at the last session of the Legislature.

Birmingham Council. A special meeting of Birmingham Council was held Tuesday evening at the office of Burgess Salisbury, on Wilkins street.

Members present—Messrs. Redman, Thomas, McVaine, Aterbury, Welker, Ward and Burgess Salisbury.

On motion of Mr. Thomas, the reading of the minutes was dispensed with.

The Burgess stated that the meeting was held for the purpose of hearing reports and making settlements with borough officers.

The account of Mr. Daniel Berg, tax collector, was presented as follows:

The Collector's report shows a large list for persons on the tax duplicate for the year 1892, who have not paid their taxes. They are generally marked "found," "left town," "can't get any thing," "quitted," "left," "went down under the heading of 'lost taxes,'"

The report of the Collector was accepted as correct. According to the Collector's report, two hundred and ninety-one persons are exempted by law from the payment of bounty tax. The amount of exemptions is \$88,725.
