A New People Discovered in Africa—A Race Like the Anglo-Saxon of Asiatic Africa, Secretary, Hon. J. S. Robinson, Treasurer, ex-Governor Dennison, J. P. Hall, J. O. Howard and Colonel W. R. Thrall, of Columbus. The gentlemen composing this committee have had much to do in state politics, and are earnest workers.

In the southwestern portion of Africa is a tract about 300 miles in breadth, from north to south, and between 400 and 600 in length, from east to west, laid down on the maps as Herero Land or Damara Land. It extends from the Cueno river, on the north, to Walvisch Bay, on the south, and from the coast to Lake Ngami, in the interior. Very few Europeans have visited this tract, and it is known only between 1857 and 1864.
