THE LAW OF MURDER.—The Supreme Court of Indiana, on Monday last, made a decision in a case which before then appeared that no more would be heard of the law of murder. The court, however, announced, and reduced the crime of killing from murder to manslaughter. This is but an iteration of the old legal doctrine.

FOR WHOM IT MAY CONCERN.—Just at this moment, when the harbor movement in Cuba has been driven to its last extremity, the rumors multiply that our own Government stands in danger of being deluged into direct acts of sympathy, instead of direct aid to the disaffected cause.

Our own claims, upon England, for the vast sum which represents the injuries done upon our material interests by her illegal and arbitrarily imposed upon our Southern reefs, will be stripped at once of all their moral force, and could never be effectively re-agitated. Our immense public debt would be again swollen, and the day for its liquidation would be postponed for generations to come.

The era of irremediable paper-money, of financial embarrassment, and of general national distress, would be indefinitely prolonged. We should have more means instead of less, and the popular ability to meet them would be diminished in the inverse ratio to our growing burdens.

THE PERTINENT QUESTION.—As yesterday suggested, the New York Herald insists, very unjustly, that the current legal proceedings, in the case of the Spanish gunboat, was reported to, by the Administration, as a subterfuge to cloak the official friendship for the cause of the Cuban revolt. Taking the Herald's stand point, its view is hardly justifiable in the following language: "If we are to believe with Spain in the Cuban insurgents, let us not forget that the United States is a free and independent nation, and that it is not to be treated as a mere ally or a subordinate of any other power."
