### BOROUGH ORDINANCE.

Be it enacted by the Chief Burgess and Common Council of the Borough of Stroudsburg, and it is hereby enacted by the authority of the same,

That Franklin Street be graded, paved with good brick, and curbed with stone, on both sides of said street, from Elizabeth street to Monroe street, and around the public buildings on said street, by the first day of August next. The same to be done under the direction of the Town Council, and according to the survey—as to height and width made by the said Council.

And further, If any person or persons owning property on said Franklin street, neglect or refuse to have the same graded, paved and curbed in pursuance of the above enactment, within the time therein specified, the said Council after the expiration of the said time, will have the same done at the expense of said owners of property according to the act of Assembly, in such case made and provided.

Be it enacted by the Chief Burgess and Common Council of the Borough of Stroudsburg, and it is hereby enacted by the authority of the same,

That the south side of Elizabeth street, from Jacob Street to the lower end of the lot now occupied by John Boys, be graded, paved with good brick, and curbed with stone on or before the first day of September next.
