



The General Land Office, at Washington, has decided that bounty land warrants are personal property, and cannot be sold by an administrator for payment of the debts of the party to whom issued. If issued during the lifetime of the warrentee, and not disposed of by him, it be longs to the heirs at law. If he dies intestate, it becomes the absolute property of the widow or legatees; and if issued af. ter the warantee's death, it becomes the property of the widow or heirs at law. without regard to age.
