

NEW INSANE HOSPITAL.

The following is the text of the bill for a new hospital for the insane, just passed by the Legislature. It applies to the southeastern counties of Pennsylvania, which are now unprovided with an institution of the kind. The establishment of this hospital has been strongly urged by the State Medical Society, and it has been warmly advocated by Dr. Curwen of Harrisburg.

An act to provide for the selection of a site and the erection of a State hospital for the insane for the city and county of Philadelphia, and the counties of Bucks, Montgomery, Lehigh, Northampton, Monroe, Delaware and Chester, to be called the "State Hospital for the Insane for the Southeastern District of Pennsylvania"; and for the management of the same.

SECTION 1. Be it enacted, That the Governor shall appoint nine commissioners to select a site and build a hospital for the insane for the Southeastern district of Pennsylvania, embracing the city and county of Philadelphia, and the counties of Bucks, Montgomery, Lehigh, Northampton, Monmissioners to be chosen from citizens of the city and county of Philadelphia, and one from each of the other counties embraced in the district aforesaid, who shall serve without compensation.
