ARRIVAL OF THE CITY OF BALTIMORE.

FOUR DAYS LATER FROM EUROPE.
Arrangements for the Peace Congress—Another French Loan—The Reform Contest in England.

New York, April 12.

The steamship City of Baltimore arrived this morning, with Liverpool dates to the 30th ult.

There was less confidence in peace, at Paris, Vienna and Turin, where warlike preparations continued.

The Paris Bourse was depressed, three per cent. Rentes closing at 68. 10cts. The report of a pending French loan was expected to have some influence in the depression.

The Reform debate in Parliament was continued every night. A vote was to be taken on the 31st. The Ministers have staked their fate on the issue. The other Journals consider their resignation certain.

The Danish Conflict was expected to continue the week. The business will be settled in one or two sessions, all the Powers having agreed to recognize the Conventions election.

The meeting of the Peace Congress, it is generally supposed, will be between the 15th and 20th of April.

The telegraphic advice by the Calcutta mail of the 25th of February, embrace nothing important. Imports and freights were drooping. Exchange was quoted 24. 15. a 24. 14d. The Hong Kong rates were to February 15th; Exchange, 24. 15.; freights flat.

It was confidently asserted that the Congress would be held in the Grand Duchy of Baden, and most likely in the town of Baden.

The Paris *Prose* says that Austria justifies the assertion that it is the mission of Lord Cowley which has rendered the Congress possible.

The English Government is said to have given its consent to the admission of Baden to the Congress.

According to some authorities the Congress will meet between the 15th and 20th of April.

The Vienna correspondent of the London *Times* says that although Austria has promised to attend the Congress, she is not inclined to think peace will be maintained, and consequently continues her armaments.

Le Nord says that Count Cavour's note to the first powers, claiming the admission of Piedmont to the Congress, points out that if they would assure us at once the right of nationality and of order in Italy—By excluding Piedmont they would absolve the fate of Italy to revolutionary influences.

The Paris correspondent of the Daily *News* asserts that armaments were going on in France without relaxation.

The Paris *Prose* adds that Government had decided upon arming a fourth battalion to each of the numbered infantry regiments of the line. The new battalions are to be formed out of the 3d and 4th companies of the already existing battalions.

Letters from Piedmont announce that between the 2nd and 25th of March, 1,400 Austrians were 50,000, 150 barrels of powder and a small quantity of gunpowder received there. The church was converted into a flour-mill.

A report was in circulation in Paris on the 25th, (but it had not been confirmed) that a collision had taken place in Lombardy between an Austrian detachment and some recruits who wished to escape the service. It is said that one man was killed and several wounded in the melee.

It is officially announced that the Federal Assembly had voted supplies for arming the federal forces with the necessary artillery. Prince Frederick of Wurtemberg is said to have been appointed Commissioner in chief of the 6th Federal corps of Armies.

A FATAL MURDER OF AN INFANT BY ITS FATHER.

A man named William Joy, says the Washington *Advertiser*, was sentenced on Saturday week to eighteen years to confinement in the penitentiary, for having his son shot dead in the basement, for having committed in the Fall of 1857, but undetected by the family through fear of the father, till he arose for another purpose, lately gave them an opportunity to tell all without fear. The principal witness against him was his little daughter Nancy, whose story to the jury is thus given by the *Intelligencer*.

Her little brother John, a child about four months old, was quite well, and had been so for some days, and was consequently fractious, and had cried considerably during the night and disturbed his father. Early in the morning his father called to his bed to get up and make a shift. She did so, made the fire, prepared a breakfast, because there was no other meal prepared. After the fire began to burn, the child continued to cry as a fact, her father became enraged, and snatched the child from its mother's arms, tore every particle of clothing off it, and then took it by one arm and one leg, and held it over the fire until it was burned in several places to a blister. He then struck the little sufferer two blows with his hand resting upon its only marks of punishment, and then took it into the grade of hell, where it lay, and digested strength to get up again, and then again lay down to digest again in mind and form. The crushing influences of such a punishment were nearly said to a strong degree, fixed to it, and carried on, and carried on nothing whatever. The drop fell at a very minute after eleven o'clock, and the four hours past the penalty of their crimes to the vast degree. Corrie and Gambrell died instantly, but Croppa and Stevens struggled severely. The legs were permitted to hang thirty minutes, and were then cut down and handed to their relatives.

Croppa has left the following brief note in the hands of the clergy, with a request that it should not be opened until his death. It was written at nine o'clock this morning.

"It was me that shot Rigidin, but I have repented of it."
