GOVERNMENT DESPATCHES FROM PEN-BACOLA.

ATTACK ON & STRAMER.

By order of the Government, the steamer Mount Vernon has been cruising up and down the Potomac for about a week past. On Wednesday last, when about fifty miles below the city, she was attacked by twenty men in boats. A short conflict ensued, but the fifty marines on board presented so formidable an appearance, that the attacking party fied to the shore.

DESPATCHES FROM PENSCOLA.

The Government has received despatches from Pensacola. The people at Warrington are represented to be in distress. They were mostly employees of the United States, but or present have no work. An interview took place on April 19th, between General Bragg and Lientenant Slemer, but with what result 1 am not able to say. Seven vessels are off the const-the Atlautic baving arrived on April 16th, and six or seven thousand Sacession troops maintaining the seige of the Fort. The Secessionists are reported to bave hung the Postmaster at Warrington, who was appointed originally by the Federal Governmeut.

GOODS RECOVERED.

At the time of the conflict in Baltimore, the Massachusetts Regiment lost their bag gage. It was, however, carefully taken care of by the authorities, and to day was received. at this place. A messenger leaves here to day having

charge three corpses of those killed at Balti-more, and who have died since. He takes them to Boston for interment.

BOLD MOVEMENT IN BALTIMORE HARBOR. Special Despatch to the Inquirer.

BALTINGER, April 27 - A bold move was made yesterday by the Government. The propeller New York arrived here from Anna polie during the afternoon, and proceeded to the dock where the receiving ship Allegbeny was moored, and after that vessel had made the necessary preparations, towed her down to Fort McHenry, where she will remain in safety under the guns of the Fort, Capt. Hunter, of the New York, kept the American colors flying on his boat, but so sudden was the movement; that it was successful before the Baltimbreans were aware of what was being transacted. ANNAPOLIS, April 26, 1861.-On Thursday

night another outrage was committed on the road to the Junction, and about three miles from that terminas. The train which left here about midnight, and in which were seated Gen. W. H. Keim, and Staff, Carl Schortz and others, passed safely through. but upon the return, an hour later, the employees and Col. Vosburgh, who was on the tender, met with a narrow escape.

At a point where the road is about thirty feet above the level of the country, the spikes had been removed from the chairs, and the rail partially turned. The locomotive and several of the freight cars were thrown from the track and badly damaged, and Col Vosborgh had his leg considerably strained

A Nucleus for a Standing Army-Three and five Years Enlistment for the Volunteers-18.000 Sailors to be placed in the Service. WASHINGTON, April 29 .- The Government to day formally decided to receive 40,000 of the 75,000 volutieers, recently called for by proclamation, for the term of three years ;-25,000 for five years ; and 18,000 sailors for

the same period. Orders to carry this measure into effect will be at once issued. An armory, in place of that at Harper's Ferry, is to be established at Rock Island, Illinois.

[SECOND DESPATCH] WASHINGTON, April 29.—The military order of to-day is not altogether correctly stated in the first despatch.

The troops called out by the order are all additional to the 75,000 already required, so that the whole number called for by the Government are volunteers. In addition to these 75,000 volunteers, who

are for three months, 40,000 are called for three years' service, 25,000 for five years' service, and 18,000 seamen for the same term,-

making a total of 158,000 troops. Even this number fulls short of the real number, as several of the States send double the number of regiments asked for. A large number of additional volunteers

arrived from Annapolis yesterday and to day.

HARRISBURG, April 27 .- Col. McClure re turned from the camp at York to night, and reports all right there, and the men are eager to march through Baltimore.

Butteries of artillery are being formed at Chambersburg, and other points of the interior, to protect any forward movements of the Pennsylvania volunteers.

BEAUREGARD AT ALEXANDRIA-THE TROOPS.

WASHINGTON, April 29 - Gen. Beauvegard has visited Alexandria, and has examined the Arlington heights, which with the Alexandria causi, from a key point, either for offence or defence. It is said, however _that the Federal Government will not take pos ression of those beights, because it would be an act of aggression, which it disclaims, but that means are devised whereby a hostile force may be dislodged from that point.

It is stated that the company of General Lane, of Kansas notoriely, consists of between four and five hundred meu, principally from the Northwest, and known as the Frontier Guards. The men are armed with Minie rifles, sword bayonets, navy revolvers, and with small patent pistols and bowie knife concealed.

The Secretaries of the Ladles' Washington National Monument Society acknowledges the receipt of seven dollars and twenty one cents from the Senate of the United States contributed during two sessions in a box placed in the Post Office of that body.


