king blackberry wine : "There is no wine equal to the blackberry when properly made, either in flavor or for medicinal pur-pose, and all persons who can conveniently do so should manufacture enough for their own use every year, as it is invaluable in sickness as a tonic, and nothing is a beiter remedy for bowel diseases. We, therefore, give the receipt for making it, and having tried it ourselves, we speak advisedly on the subject : Measure your berries and bruise them; to every gal-ton adding one quart of boiling water. Let the mixture stand twenty-four hours, stirring occasion-ally; then strain off the liquor into a cask, to every gallon adding two pounds of sugar; cork tight, and let it stand till the following October, and you will have wine ready for use, without further straining or boiling. 




