She had not seen him for twenty or twenty-five years, and was anxious that he should pass the few remaining days of his life, free from the cares of this world. under her roof. He sailed from Liverpoo in a steamer belonging to the Red Star Line, called the Abbottsford, the latter part of last mouth, and arrived safely at Philadelphia on Monday the 17th inst., where he was furnished transportation by the steamship Co., via. Penna. Cent. & N. C. R. R. to Danville. As is so frequent the case recently, that train was delayed and missed the D. H. & W. connection at Sunbury, and he got off the train at the latter place, a stranger in a strange land and knew not where to go. Being auxious to reach his destination, and learning that Danville was only ten miles distant, he started to walk here on the railroad track. A few miles this side of Sunbury he accidentally fell through a trussel bridge and injured himself severely. He got up, however, and proceeded on his journey, leaving the track and taking to the wagon road. After going a short distance, it seems the Injuries 1 received in the fall began to take effect and he sought a neighboring house for rest and reliof. He was admitted and cared for but only lived a few hours. Thus, after traveling thousands of miles to reach his kin, he died when he had nearly accomplished his journey almost within sight of his children, but without being permitted to enjoy their idial affection. An Old German Woman Attacked.

DEAD. For the past twenty-five years an old German woman, whose name is supposed to be Catharine Krohl, but who was familiarly known as "Old Aunt Katrina," has occupied a building in what is known as 'Peet's Hollow," which is situated in the First ward and below Mish's farm, above Eleventh street. She was a freebooter, as no one ever asked her for rent and no one molested her. Why she lived all alone in such a secluded place no one knows. She was inoffensives and attended to her own business, and is between 70 and 80 years of age. None of the people in the vicinity seem to know anything of her antecedents or her business, and no one would have thought there was any danger of her being molest-Last evening word was brought to the

Mayor's office that she had been brutally beaten, and was lying in a precarious condition in the building she called her home. Near the door was a pool of blood, and blood was splattered around the room. COLLISION AT SEA.

STEAMER VILLE DU HAVRE SUNK.

226 Lives Lost.

ONLY 87 OF THE CREW AND PASSENGERS SAVED.

NEW YORK, Dec. 1.

Ville du Havre:

The ship Trimountain, from New York, arrived at Cardiff at an early hour this morning, bringing intelligence of a dreadful disaster to the steamship Ville du Havre, which left New York November 15, for Havre, under command of Captain rmout. At two o'clock in the morning 23d November, the Ville du Hayre collided with the British ship Kock Earm, London for New York, and sunk shortly after. Two hundred and twenty-six of the passengers on the steamer lost their lives. The Trimountian rescued eighty-seven of the passengers and crew and brought them to Car-

FURTHER PARTICULARS.

NEW YORK, Dec. 1 No steerage passengers are carried by any of the vessels of the line to Havre. The cabin passengers numbered 130, and the crew, it was said at the office of the company, about 150, although the number

was not known exactly.
Captain M. Surmont, the commander of the Ville du Havre, is fleet commodore, and has been in the service of the line since its organization. He has borne a high renutation as an efficient officer. The officers of the Ville du Havre re-

ported saved are the captain, second officer, third officer, fourth officer and purser. DAMAGE TO THE LOCHEARN.

ONLY TWO BOATS LAUNCHED
