If "Tax Payer" intended to be fair, he would have stated the fact that his figures were taken from a partial report made in 1872. Perhaps this "Tax Payer" should have a lucrative office bestowed upon him by the borough officials, who would take a different view of the case, and the facts as they exist, and would not try to play a part of the long and arduous and really described in "Tax Payer's" Fabrics. If "Tax Payer" cannot find better employment than that of figuring out the borough audits for deceptive purposes, we would advise the council to give him a position suitable to his (we will say nothing about mental) physical capacity, for instance, putting up an array of posts along railroad fifty feet apart to the end of the road, or the crossing; or let him run with the "fire machine," or any other easy position.

SALE OF THE SUNBURY AND LEWISTOWN RAILROAD.—The sale of the Sunbury and Lewistown railroad came off at the Merchants Exchange, Philadelphia, on Monday last. The whole line of the road was sold, beginning at the north side of the Sunbury car, in this county, opposite Selingsgrove, and ending at Lewistown, a distance of forty-two miles, together with all its appurtenances, real estate, tracks, stations, stock, everything in fact which belonged to the company. There was great bidding for a while, but the road was at last struck down to Malcolm Campbell, attorney for certain bondholders, at \$250,000, subject to a mortgage of \$1,200,000.
