FELLOW CITIZENS OF THE SENATE AND HOUSE OF REPRESENTATIVES: With devout gratitude to the bountiful Giver of all Good, I congratulate you that at the beginning of your first regular session you find our country blessed with health, peace and abundant harvest, and with encouraging prospects of an early return of prosperity.
