The candidates have been numerous here for the past week; the boys say they won't vote for them, for they didn't set up there.

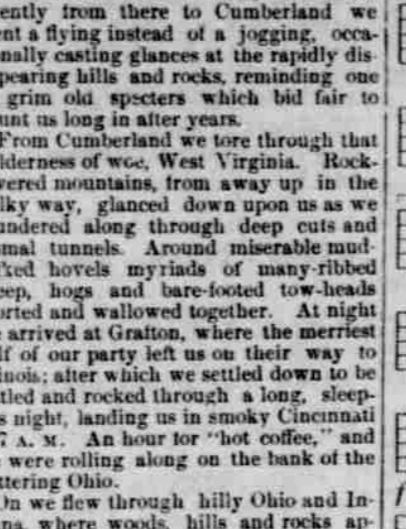
