COURT PROCEEDINGS.—Court convened on Monday last.

The number of persons present was unusually large, much interest being manifested in the Krieger and Weigley cases. Owing to so many of the cases being of a criminal nature, the court adjourned on Thursday morning at 10 o'clock.

Com. vs. Albert A. Krieger, assault and battery with intent to commit murder, on information of John S. Engle. Particulars of the shooting were published at the time in the HERALD, and will doubtless be remembered. Engle has since recovered from the effects of the shot, and appeared in as good condition as though he had never been lacerated. The defendant denied the shooting, but pleaded extreme provocation in justification thereof. After a short absence from the court, the jury returned a verdict of guilty as to the second count of the indictment, whereupon Court sentenced defendant to the penitentiary for one year, a fine of \$100, and undergo an imprisonment for six months in the county jail.

Com. vs. George Verlin, F. and E., on information of Lucinda Tressler, verdict guilty, the usual sentence was imposed by the Court.

Com. vs. Henry P. Hinesbaugh, F. and E., with intent to kill. The evidence in this case developed the fact that it was a general and heated quarrel which resulted in a death, when Mr. John Cameron got himself pretty badly used up by being hit on the head with a stone thrown from the back of Hinesbaugh's head. The verdict of assault and battery, and the same day the Court sentenced the defendant to the penitentiary for one year, and undergo an imprisonment in the county jail for one month.
