

PENSION LEGISLATION.

WASHINGTON, D. C., January 25.—Senator Davis, from the Committee on Pensions, today reported favorably a bill (known as the Grand Army bill) to pension ex-soldiers and soldiers who are incapacitated for manual labor, and provide pensions for dependent relatives of deceased soldiers. The bill has the support of the majority of the committee, and is expected to pass the House in a few days.

The President should have waited until June before attempting to shed the burden of the United States. It was a bad blunder.

Those who failed in his contest for Speaker Carlisle's seat, will have an opportunity to fight the wrong committed by the Democratic majority in Congress.

Last week witnessed the most extensive cold wave of recent years. Beginning in the far northwest where its terrible effects are shown by the number of people frozen to death, it swept over the entire country.

Mr. McManis, the Republican leader in Philadelphia, who will be a delegate to the National Convention, insists that he is for George W. Childs for President, and will vote for his nomination, notwithstanding Mr. Childs's positive refusal to be a candidate and declaration that he would decline the nomination if tendered him.

Secretary Bayard declares that the President's gift to the Pope was that of a private citizen. All the same it was presented in the name of the President of the United States and not Grover Cleveland.

The bill giving the widow of General John A. Logan a pension of \$2,000 a year passed the Senate after debate, by a vote of 55 to 7. A similar bill was then passed increasing to \$2,000 a year the pension of the widow of General Frank P. Blair.

The Senate passed the bill increasing the pension for total deafness to \$300 a month and allowing a proportionate rating for partial deafness. Mr. Quay stated that the increased expense would not exceed \$100,000 a year.

The magnitude of the strike in the Pennsylvania coal regions may be judged from the fact that, instead of 300,000 tons of coal, which is the ordinary January product, the output this month will be next to nothing, and the \$400,000 wages which the company would have paid to its miners for their month's work will be entirely withheld from them.

The commission appointed by the New York legislature to inquire and report as to the best method of inflicting the death penalty, after a thorough and careful examination of the methods practiced in civilized countries, propose to amend the present statutory penalty by substituting electricity for the gallows.

The method proposed will be sudden silent, painless and infallibly efficient. There is a very general desire among the American people that the present barbarous and inhuman method of execution shall be done away with, and that if a human life must be taken to satisfy the requirements of society it should be done as painlessly and mercifully as possible.

In most countries the instruments of the executioner are the sword and the guillotine, but the advantages they possess over the halter are not great enough to make it worth while to change. They are quicker and surer, and they put an end to all hope of resurrection, but they produce such ghastly spectacles as to horrify the most stolid of official life-takers.

The one fact which has operated so long to retain the gallows is that its victim, if he is disgraced, at least is entire. He is not mutilated. His blood is not drawn. Criminals whose moral instincts seem to be wholly gone and who have not enough spirituality to care for their souls, often display much feeling concerning the fate of their dead bodies. They should be deprived of the slight satisfaction to be taken from the knowledge that they can go to their graves without suffering actual dismemberment.

Every claim of justice and every argument of mercy are satisfied by the use of electricity. Concerning its efficacy in dealing the death-blow, the commission has produced voluminous and convincing testimony. Recent medical and scientific men have furnished the commission with the results of experiments upon animals quite as treacherous of life as man, and have shown just what machinery is needed to carry out the capital sentence. It could be provided at an expense of from \$250 to \$500. It would consist of a slightly reclining chair with a metallic head and foot rest. Into the electrodes would be fastened. The current would thus pass through all the centres of function and intelligence and death would be so instantaneous that sensation could not be possible.

The commission also recommended that all executions occur in one specified place, and that convicts from the various counties be sent thither as soon as sentence is imposed. The warden of the prison shall select the day of execution, and twenty-one citizens shall be present as witnesses—all of whom may be newspaper reporters, but it is desired to prevent the publication of descriptive reports.

The body is to be delivered to a medical college for dissection or buried in a prison graveyard in order to escape public gawking that we are continually hearing of. While some of the details are open to severe criticism, the general recommendation to supplant the gallows, strangulation and the guillotine with the instantaneous death of the painless and undoubtedly humane.
