Kearsarge, which during the war sank the privateer Alabama, was wreck- ed on Ruocador Roef, in the Caribbean Sea, on February 2. All on board reached the little desert island in safety, where they are awaiting their rescue by a steamer from Colon. Admiral Stanton was in command of the Kearsarge. Roseador reef is situated about 200 miles off the coast of Nicaragna and is one of the most dangerous menaces to navigation in the world. Efforts have been made by mariners to secure the erection of a light house on the reef, but without success. Every patriotic citizen will read with regret of the loss of the Kearsarge, the most famous naval relic of the War. The story of her sea fight with the Alabama revived the reputation of American sailors estabilished by Paul Jones and Decatur. The ships were evenly matched; their commanders had heen classmates; but the Alabama was man- ned by English sailors, the Kearsarge by American. In a perfectly fair duel the Kearsarge won, and only up the cureer of Scimpos, the commander of the Alabama, who had been for a long 'time robbing un- aroued ressels.
