Got Their Meney at Last.

FLIZABETH, N. J., Jan. 17,-A decision was handed down to-day by Vice Chancallor Emory by which five young men will have divided equally among them about \$1200 in cash. The case has been in the courts for nearly 25 years. On August 27, 1870, William Cashman, Thomas Fox, Robert Devine, Charles Fox and William Crawford, then boys, ere roaming along the banks of the Elizabeth River when Crawford picked up an old stocking full of something. Crawford began to swing the stocking as a plaything. Each took a turn bitting the others with it. Finally it burst and a roll of bills came out. The boys counted \$755. They started to divide the cash, but were interrupted and finally took it to Fox's father, who turned it over to John Kerron, then Chief of Police. Nobody every claimed it, and then Crawford wanted it all, claiming he had found it be equally divided, and the case was earried to court, where it has lain ever since. The money, having been deposited, has been drawing interest. Three of the boys are now married. The ease, according to the Vice Chancellor, never has had a parallel.

The Wife Stopped His Pension. FRANKLIN, Ind., Jan. 16,-Willis H Hampton, who resides near Taylorsville, has been deprived of his pension in a peculiar manner. He has been drawing \$17 50 a month for a long time. Some time ago had a disagreement with his wife. Mr. Hampton secured a divorce. and his wife went West. Some weeks ago she wrote to her former hasband that unless he sent her \$50 at once she would see that his pension was stopped. Mr. Hampton refused the request, and thought the threat idle. The woman put herself in communication with a special pension examiner, and the result was that Mr Hampton was re-rated, reducing his pension from \$17.50 to \$12.a mouth, the reduction to antedate to the time of original issue. Hampton has already drawn \$1,429 47 more than he is entitled to, and in consequence the Pension Department refuses to allow him to file his voucher again until the year 1999, by which time the amount alleged to have been overdrawn will be offset or covered back into the Treasury of the United States.

Cleveland Will Not Run ..

WASHINGTON, Jan. 19.-Members of the Democratic national committee are authority for the statement that Mr. Cleveland has announced positively that he Thurman, of Ohio. will not have a renomination. The men making this statement will not permit their names to be used. The statement has been made to their colleagues on the committee by two or three of the com mitteemen who are friendly to Mr. Cleveland and have talked with him on the subject that Mr. Cleveland voluntarily announced to them that he would not run for a third term and authorized them

to let the committee understand this. Mr. Cleveland is quoted as saving that he does not feel called upon to make an mouncement in the newspapers, but would like his friends on the national committee to know his position. These confidants of Mr. Cleveland go further and say that if anything should occur to warrant his doing so, Mr. Cleveland will at the proper time make a formal announcement, taking strong grounds against a third term.

The Democratic national convention will be held at Chicago on July 7, Such was the decision reached on the twentyninth ballot by the national committee after a spirited contest in which Chicago only two votes behind.

What Farm Hands Earn. Secretary Edge's annual report of the epartment of agriculture deals with the ork of the re-organized department and tlines what is proposed to be done this year by each of the bureaus. Especial attention is directed to the efforts to stamp out the traffic in oleomargarine and adulterated food products.

The report is voluminous and gives

auch valuable information. The average salaries paid farm hands, employed for the year by the month and boarded by the employer, is \$12.00, while, when the hand boards himself, he receives \$19.01. During harvest time he receives \$1.37 by the first plan and \$2.02 by the latter. The employer estimates that it costs 34 cents a day to board the hand, while the hand estimates that it have cost China II,600,000 of lives. costs him about 21 cents a day to board timself. The difference of 88 cents a week is made up by the hired help doing more work for his employer, because he is there to do the chores when his emdoyer boards him.

In order that the department might know just where adulterations might be expected, and the extent to which they are practiced, Secretary Edge ordered the selection of a large number of articles of food and food products in various parts of the state, and these samples were sent to the chemists of the tenertment for examination, analysis and report. The result of this action thus far proves that such adulterations are largely confined to the substitution of lower grade articles for the purpose of enabling manufacturers and dealers to compete with other low grade goods, The cases in which materials injurous to health are used as adulterants are rare, and, except in the case of the use of copper for coloring pickles, might possibly be attributed to accident rather

than design The official reporters of the departnent have been utilized for the collection of a large amount of data relating to the prices of different kinds of farm live stock, and sundry other items of interest to the general farmer. It is proposed, during the coming year, to stil further utilize this branch of the department in obtaining regular reports as to the acreage, condition and yield of the leading farm crops and the condition of live stock in each county in the

Horrors of Filled Cheese.

Agent F. N. Moore, of the State Food and Dairy commission, has about con cluded his investigations into the extent to which adulterated, or filled, cheese has been sold in Pittsburg. Mr. Moore says nothing but eternal vigilance will prevent the filled product from driving the pure cheese from the market. He said filled cheese was a fraud from a hygienie and financial standpoint and a menace to public health. The filled cheese manufacturer subjects the cheese a process which extracts from it butter fat, its most valuable and costly ingredient. Continuing, Agent Moore

ounds and requiring 400 pounds of milk. should contain 16 pounds of butter, and the money. The others demanded that the maker of filled cheese extracts almost four-fifths of this butter fat, the most nutritious part of milk, and substitutes foreign fats, the cheapest and most injurious, of course. Cottonseed oil is used, and that is not fit for food. The butter fat taken out is sold and nets the manufacturer about \$2.50 for each 45pound cheese, and in its place is put either neutral lard or cottonseed oil. The former costs 7 cents a pound, or Si cents for the cheese, and the latter 4 cents 2 pound, or 36 cents for the choese. The full cream cheese is worth at the factory 8 cents a pound, or \$3.60, and the many facturer takes out almost \$2.60 of this, making the filled product, selling in the guise of pure cheese, a monstrous swindie. The law is very clear in regard to this, and both the swindling feature and the injuriousness of the adulteration are good grounds for prosecution. Both neutral lard and the cottonseed oil are unfit for food, and the latter particularly

Mr. Moore is at present giving attention to the manner in which adulterated and deleterious foods for infants are sold as pure, barmless and nourishing. He has received letters from women asking innocent baby from frands, which cause distress and morbid appetites in after life. Mr. Moore has also been informed by physicians, that much of the stuff sold as wholesome food for infants did much to rain the child for life, and created unnatural appealtes for stimulants and opiates, which proved rulnous to the child. Physicians have also told him stories of after affects of the use of some foods which can scarcely be credited. 
