Two Sons of Sunny Italy in Jail Charged With the Bloody Tragedy at Windber. FRANK NAPOLEON STILL AT LARGE.

Autonio Medina and James Trupzo, two Italians, were committed to jail

Friday morning, charged with being scessuries to the Easter night tragedy at. Windber, when hve men were slashed to death in a drunken orgie held in a brathel conducted by a dissolute French woman, named Steux, who is also in jail where she is being held as a witness.

'Squire Sell, the Windber Justice of he Pence, who has been vigilant in running the marderers to earth, was in merset Monday. He expressed the pinion that the men now in jail are not he guilty parties, although many cirumstances which have come to the knowledge of the officers of the law point to them as being able to give information

which would lead to the arrest of the murderers, if they can be induced to tell all they know about the bloody affray. Since their incarceration Medina and Trunzo have been kept separated and neither of them has been permitted to hold any conversation with the Stean


