Primary Meetings.

At a meeting of the Republican County Committee, on Tuesday evening, May 23d, 1871, Saturday, July 22d, 1871, was fixed as the day for holding the Primary Meetings this year. The Republican voters of Forest County will meet at the usual places for holding elections in each election district on Saturday, July, 22d, 1871, at 1 o'clock, P. M., to nominate candidates for the following offices:

One person for President Judge.
One person for Assembly.
One person for Co. Commissioner.
One person for County Auditor.

The Republican voters of each election district at the same time elect by ballot one person to serve as a member of the County Committee for one year, and return the name of such person and his vote in the same manner as those of the candidates for nomination.

Each Election Board shall constitute the newly elected member of the County Committee the Return Judge of said district, who shall make his returns at the Court House, in Tionesta, on Tuesday, July 25th, 1871, at 2 o'clock P. M., at which time the committee will also elect their Chairman for the ensuing year.

Every Republican in Forest County is earnestly requested to turn out at the Primary meetings and assist in nominating good and efficient persons for the different offices.

By ORDER OF THE COMMITTEE.

The Democracy of Forest has signified its endorsement of Jenks, of Jefferson, for President Judge. Jefferson having no other candidate, of course must do likewise. The Primary elections of Jefferson took place yesterday, but we have no figures yet. However, there can be but one result there, the election of Jenks for the candidate of the Democracy of that county for President Judge. Clarion, who held her primary elections on the same day that Forest did (by special arrangement,) endorsed Corbett, and seem bound that he shall carry the day, whether or no. The custom has heretofore been to appoint three conferees from each county, and abide their decision. Had this been the programme this time, Jenks would have been nominated on the first ballot. But Clarion has a large majority of all the Democratic votes in this Judicial District; and fails to see the justice of the majority submitting to the minority, therefore, the Clarion county convention appointed six conferees to meet three from each of the other counties, claiming the power as a right by virtue of her vote. There seems to be a disposition among the Jenks men to dispute this power to swerve from the usages of the party, and a determination on the part of the Corbett men to stick to it. The following are the probable and resolutions reported and adopted by the convention, which may explain the state of things better than we can:

WHEREAS, The County of Forest has changed its usage and custom by changing the time of holding its county convention from the month of August to the date of holding the convention in this (Clarion county) thereby refusing the candidate presented by this convention, for President Judge of this District, a hearing before the people of Forest county; and this has been done when said county of Forest presents no candidate of her own, and insures said county to the support of the single candidate presented by Jefferson county. Therefore be it.

Resolved, That this convention suggests a representation in the judicial convention of the District, equal to the Democratic vote in the district, and we suggest as a basis, one vote for every

five hundred democratic votes or fractional part thereof, and that such basis of representation be determined on the last general election for Governor.

Resolved, That this convention unanimously present the name of Wm. L. Corbett, Esq., for President Judge of this judicial district, and elect six conferees under this suggestion to represent the county in the district convention.

Resolved, That W. W. Barr, J. B. Knox, Alexander Hindman, S. H. Hagan, Anthony Beck, and H. H. Neely are hereby appointed judicial conferees.
