

-By a private letter from a friend Notice U. S. Internal-Revenue Special Taxes.

> Under the Revised Statutes of the United States, Sections 3232, 3237, 3238, and 3238, and 3139, every person engaged in any business, avocation, or employment, which renders him liable to a special tax, is required to procure and place and keep conspicuously in his establishment or place of business a STAMP densting the payment of said special tax for the special-tax year beginning May 1, 1878. Section 3224. Revised Statutes, designates who are liable to special tax. A return, as prescribed on Form 11, is also required by law of every person liable to special tax as above. Severe penalties are prescribed for non-compliance with the foregoing requirements, or for continuing in business after April 30, 1878, without payment of tax.
