

TIONESTA, PA., April 20, 1878. The Republican County Committee of Forest County met in Tionesta Borough on April 19, 1878, pursuant to Agnew. All members were present except those from Howe, Hickory and was elected Secretary.

MINUTES

Hon. J. B. Agnew was chosen Representative Delegate to the State Conention, and is uninstructed.

The question of arranging for apointment of Senatorial Delegate was eft to L. Agnew, chairman, to copfer with other counties in the district.

The Republican Primary Elections were fixed for Saturday, June 22d, 1878, from 2 to 7 o'clock P. M.

W. E. Lathy, Esq. proposed the following amendment to a section of the Crawford County System, to-wit :

"The section of the Crawford County System adopted by Forest County Republicans as their system, which provides that if three or more Democrats vote at a Republican primary election in any primary election district, the whole poll of said district shall be thrown out and not counted, is hereby Harrisburg, at twelve o'clock noon on so amended, that only the votes of those Democrats so voting shall be thrown out, and the balance of the pell shall be counted."

On motion of Mr. Lathy, is was resolved that the question of the adoption or rejection of said amendment be voted upon at the Republican primaries, on June 22d next, the ballots to be used in the premises to have printed thereon "For Amendment" and "Against Amendment."

On motion of Mr. John Thompson, of Harmony Twp., the Committee passed the following resolution :


