A DEMOOCRAT'S OATH.

The legislative apportionment bill gives three members to Northumberland county. There is 53,123 population in that county, and about 1,-500 Democratic majority. The Constitution : "Every county containing less than five ratios shall have one representative for every full ratio and an additional representative when the surplus exceeds half a ratio." The population of the State by the last censos was 4,282,786. The Constitution says: "The members shall be apportioned among the several counties on a ratio obtained by dividing the population of the State by two hundred." A ratio therefore, is 21,414; two full ratios, 43,828; one-half a ratio 10,797. In order therefore, to be entitled to three members, a county must have 53,535 population. The county of Northumberland is therefore 412 short of the number fixed by the Constitution as requisite for such representation. Democratic members of the Heuse took a solemn oath to obey this Constitution. They are reformers, elected on a tidal wave of reform and placed in power by the salfrighteous Independents. This is but one of the iniquitous features of the bill they have passed. Is this reform? Is it not a plain, palpable violution of the solemn oath they took, as members of the House? A thousand Republicans of Erie county, in' a blind fury against alleged evils in their party, went back on their candidates and helped put this horde into power. Erie county has almost 75,000 population, but by this Democratic reform measure she is only given the same representation as the Democratic county of Northumberland, with 53,123 population. The exact population of Erie is 74,682. The three ratios for three members amount to 64,242, the surplus then is 10,430, 268 short of half a ratio, which would entitle her to the four members she new has.


