THE Morrison Tariff bill was considered by the Ways and Means committee last week, and in a short session of less than two hours the bill as introduced was so far amended as to meet with the approval of every Democratic member of the committee, and it was agreed that it should be reported this week, and an effort made to secure its passage through the House. The amendments cut off the free list with the exception of salt, coal and timber, these interests, however, being singled out for slaughter by these cowardly free traders, who fear to advocate their principle as a whole because of the effect upon the vote for President November next, they being more anxious to obtain control of the government than to maintain a principle. By the way, the Democratic organs of this county have been as dumb as clams on that subject, and from their columns it would be difficult to learn of any interest they have in the prosperity of the manufacturers of lumber in our county.
