The like punishment shall be inflicted on conviction on the officers of election who shall neglect or refuse to make or cause to be made the endorsement re-quired nforesaid on said naturalization certificate.

SEC. 12. If any election officer shall re-fuse or neglect to require such proof of the right of suffrage as is prescribed by this law, or laws to which this is a supple-ment, from any person offering to vote whose name is not on this list of assessed voters, or whose right to vote without re-order whose right to vote without requiring such proof, every person so of-fending shall, upon conviction, be ulity of a mistemeanor, and shall be sentenced for every such offense, to pay a fine not exceeding five hundred dollars, or to unlergo an imprisonment of not more than ne year, or both, at the discretion of the
