#### Election of Tax Collectors.

As the spring elections will soon be here a perusal of the following Act of Assemby will be of interest to voters :

The qualified electors of each borough and township in this Commonwealth shall, on the third Tuesday of February of each year hereafter, elect an officer to be styled Collector of taxes, whose term of office shall commence on the first Monday of April next after his election.

The Court of Quarter Sessions shall have power to fill, by appointment, all vacancies in the said office, within their respective counties. And, if any person elected to fill said office shall fail to give bond and qualify as hereinafter provided, on or before the fourth day of the term of said Court next ensuing his election the said Court shall declare his office vacant, and appoint a suitable person, resident in the proper borough or township, to fill the same.

#### OATH AND BOND.

The Collector of taxes shall, before he enters upon the duties of his office, take and subscribe an osth of office, and file the same in the office of the Court of Quartor Sessions of the proper county, and shall also enter into a bond to the Commonwealth, in double the probable amount of taxes that will come into his hands, with at least two sufficient sureties; said bond to be approved by the said Court or a Judge thereof in vacation, and in the office of the Clerk of the said Court.

The several county, borough, township, school, poor and other authorities now empowered, and which may hereafter be empowered, to levy taxes within the several bocoughs and townships of this Commonwealth, shall, on or before the first day of August of each year after the first election of Collector of taxes under this net, issue their respective duplicates of taxes assessed to the Collector of taxes of their respective boroughs and townships with their warrants attached, directing ular meeting is on the first Wednesday and authorizing him to collect the same, in February. but road taxes may be worked out as heretofore, provided, that such special and other road taxes as it may be lawful and necessary to collect in money, may, at the discretion of the Supervisors or Road Commissioners, be placed in the hands of the Collector of taxes with their warrant for collection by him; for which he shall receive five per centum of the amount collected by him or the same may be collected by the Supervisor or road Commissions as heretofore. Provided, further, that the limitations in this act, as to time and requirements hereof relating to keeping an alphabetical list of persons charged with taxes, shall not apply to road taxes.

#### POWER OF THE COLLECTOR.

The Collector of taxes shall have all the power for collection of said taxes, during his term of office, heretofore vested in Collaws, and be subject to the same liabilities and penalties for neglect, or violation of the duties of his office.

SHALL HAVE REGULAR DAYS.

The Collector of taxes shall, in person or by some person duly authorized be in attendance for the purpose of receiving and receipting for taxes on Thursday, Friday and Satufday of each week, dur-ing the last two weeks of said sixty days between the hours of 2 o clock and 6 o'clock in the afternoon, at his residence, or some other place in the proper town-ship or borough, to be designated by him in the notice aforesaid. The Collector of taxes shall collect the

taxes charged in said duplicates and pay over the same to the respective T easur-ers or authorities entitled thersto, after de-ducities between the same terms of terms of the same terms of t ducting his commission for the collection ducting his commission for the concern thereof, which is hereby fixed at two per centum on all taxes paid to him on which an abatement of five per centum is al-lowed, and at five per centum on all tax-es afterward collected: Provided, that where the total amount of taxes charged on a duplicate is less than one thousand on a duplicate is less than one thousand dollars, the said Collector shall receive three per centum on all taxes paid to him on which an abatement of five per centum is allowed.

Exonerations may be made by the authorities and in the same manner as heretofore. The accounts of Collectors of tax-es shall be settled by township or borough Auditors of the proper township or borough, and he shall state a separate account for each different tax Collector by him; but Collectors of county and State taxes shall settle with the County Com-missioners as heretofore.

Taxes charged upon unsettled lands shall not be collected by Collectors of taxes, but shall be certified and returned by the acveral authorities levying the same to the County Commissioners, to be col-lected as heretofore.
