CALL FOR THE REPUBLICAN STATE CONVENTION.
 HEADQUARTERS REPUBLICAN STATE COMMITTEE, PHILADELPHIA, June 9, 1887.
 The Republican State Convention will be held in the Opera House at Harrisburg, on the third Wednesday of August, the 17th, 1887, at 10 o'clock, a. m., for the purpose of nominating candidates for State Treasurer and Judge of the Supreme Court, and for the transaction of other business.

The attention of Republicans throughout the State is respectfully directed to the following Permanent Rules for the holding of State Conventions and the conduct of the party.
 First, That delegates to the State Convention shall be chosen in the manner in which candidates for the General Assembly are nominated.
 Second, Hereafter the State Conventions of the Republican Party shall be held not earlier than the third Wednesday of August, except in the year of the Presidential election, when it shall be held not more than thirty days previous to the day fixed for the National Convention, and except in gubernatorial years. At least sixty days' notice shall be given of the date of the State Convention.

Third, That we recommend to the county organizations, that in their rules they allow the largest freedom in the general participation in the primaries consistent with the preservation of the party organization.
 The State Convention of June 30th, 1886, having abolished Senatorial representation, Delegates to the approaching State Convention will be selected according to the number of Representatives in the Legislature to which each county or city is entitled under the Representative Apportionment law passed at the recent session of the Legislature.

THE election in Kentucky last week shows up very badly for the Democrats, they having carried the State by scarcely over 5000 majority. WHILE most of the old trade dollars have been sent in to the government depositories for redemption, there may be some who have neglected it because of the long period named by the redemption law for the exchange. The six months within which the trade dollars can be exchanged for standard silver dollars will expire on the 3d of September, and all not presented on or before that date will be valueless beyond their bullion value. The banks throughout the country generally offer facilities for the redemption of the trade dollars, and all who have thus far neglected to make the exchange should take note of the fact that the time for redemption will expire on the 3d of September.

Gettysburg Memorial Tablets.

General John P. Taylor, Millfin county; Major Samuel Harper, Pittsburg; General J. P. S. Gubin, Lebanon; Colonel R. Bruce Ricketts, Wilkes Barre, and Col. John P. Nicholson, of Philadelphia, the commission appointed to carry out the provisions of the act appropriating \$121,000 for the erection of memorial tablets on the battle field of Gettysburg to mark the positions of Pennsylvania commands, met at the Capitol Wednesday and organized by electing General Taylor president and Major Harper secretary. After hearing from regular organizations which participated in the battle a circular will be issued, requesting them to address Major Harper, the secretary, as soon as practicable, and submit designs and specifications, material and proposed location of the monument they propose to erect with the aid of the \$1,500 which the State has appropriated to each regiment and battery. This circular will state that the commission is desirous of having the hearty co-operation of the representatives of each organization entitled to avail themselves of the act. They ask for the names of the survivors of any of the Pennsylvania commands with whom they may communicate as actual participants in the engagements, to assist the commission in determining the position and movements of the regiment or battery to which they were attached.

DR. TALMAGE ON HIGH LICENSE.

A measure wrong in principle and a failure in practice—Evils are to be outlawed, not legalized—Surprised that decent men can be duped by this compromise with the devil.

The alcoholic slaughter of hundreds of thousands every year put into insignificance all the railroad accidents, and shipwrecks, and choleras, and yellow fever, and earthquakes; and now, while all our cities are standing aghast at the moral and social devastation of drunkenness, and saloons are multiplying by the hundreds, and liquor-selling associations are becoming more defiant, the Legislature of New York, with no moral courage to combat the evil by decisive legislation, is deliberating whether or not it had better propose an imbecile compromise which is called high license. In other words, it proposes to say: All you poor rum-sellers, who can only pay a small license, must quit, and all you who can pay \$500 or \$1,000 may go on with a business that is the damnation of so society. I am amazed that good men should be deluded with this compromise with the devil. Oh, some one says, it is impossible to execute a prohibitory law, and as we can't eject the evil let us put upon it this one brake. The fact that you cannot execute fully a law, is no reason why you should have a law. Which one of your laws is fully executed? You have a law against Sabbath-breaking, yet multitudes offend it every Sunday. We have a law against blasphemy, but all our jails are full of burglars highwaymen. There is a law against murder, but there are murderers in all our prisons. Since we have not been able to stop these evils of theft and arson, and blasphemy and murder, why not compromise the matter and have a high license? Give to certain men all the privilege of stealing and swearing and massacre. Get ready your Excise Commissioners. Let us have a \$5,000 or \$10,000 tax for the business of theft. Let us put an end to those small scoundrels who have genius enough only to steal house mats or postage stamps or chocolate drops, and confine the business to those who, having paid \$5,000 or \$10,000 for genteel robbery, can abscond with \$50,000 from a bank, or who, by watering the stock of a railroad company, steal \$200,000 at one clip. I would put a very high license on theft, say \$10,000, for they would soon make it up. We are fearfully opposed to sneak thieves and wharf-rats and twopenny scoundrels, but all hail two million dollar rascals! So, also, let us by high license put down blasphemy. Let us shut up the great masses of the foul-mouthed, and by the high license of \$10,000 let a few men do all the swearing of the community. Let us select, say 40, of the most impulsive men of Brooklyn, men of the highest temper and the hottest tongues and the most spiteful against God. Let these especially delegated men for a high license of \$10,000 be allowed to do all the profanity and have full sweep, while we beat down and sweep out of the community with the besom of destruction all those who swear on a small scale and have not got beyond "By George," "My stars," or "Damn it." Extirpation for all small swearers! You will never put down blasphemy in this country except by high license. So, also, let murder be licensed. The present law does not do; many persons having committed murder all over the land going scot free. The only way you will ever put an end to murder in this country is by high license; put a few men to manage the whole business. This common herd of assassins who do the work with car hooks and dull knives and Paris green must be put down, and let a few experts who can do the thing without pain and by chloroform or flash of bull dog revolver can genteelly put the victim out of his earthly misfortunes—let them have all the business. Of course, that license ought to be as high as \$20,000, because the perquisites of gold watches and money safes and plecthoric pocket-books would soon pay the high license and leave a handsome sum for net profit. You see at a glance, all ironical aside, that if rum-selling is right we all ought to have the privilege of engaging in it, and if it be wrong, \$5,000,000 paid down in hard cash as a yearly license ought to purchase no immunity. And yet, at this late period, after high license has been tried in many places, and always been a dead failure, and the production of additional mischief, and where it existed for a long time giving respectability to hard drinking, so that many men who would not be seen coming out of a low grog shop found it fashionable to come out of a gilded saloon—although in every place where high license has been tried it has been found a failure, still the proposition is to try it in the State of New York.
