Judges of Quarter Sessions of the Peace in and for the County of Forest, May Sessions, 1890 : The Grand Inquest of the Commonwealth for the County of Forest, in all matters ralating to the same, do respectfully report, that they have acted upon three bills of indictment, of which three were found true bills. We beg leave to report that we have visited and inspected the County buildings and find them generally in good repair, with the exception of the ceilings in the several Court offices, which are in need of repair. Also, we find that the vault in the Prothonotary's office has become totally inadequate for the holding of the Public Records, and recommend that the same be enlarged and made fireproof.

We further report that the river road, west side, leading from Hunter Run up the river to George King's farm in Harmony township, is in a bad condition, and unsafe for travel to the general public. We further find that the United

Pipe Line Co., have run their pipes parallel and in many places on the Public Road, leading from Marien-ville to Sheffield Junction, in Howe and Jenks townships, rendering the same dangerous, and almost impassi-ble in many places for travel, thereby greatly hindering with the proper repairing of the same, and we deem the same to be a public nuisance.


