Republican Committee Meeting.

At the call of Chairman J. I. Woods the Republican County Committee met at the Sheriff's office at the court house, Monday evening at 7:30. The Chairman called the committee to order and appointed Leon Watson secretary. He stated the object of the meeting to be to appoint a day for the holding of the Republican Primary election, as well as for the transaction of such other business as might come up.

A resolution was passed providing for a uniform ticket, that is, the printing of all the candidates' names on one ticket.

The places for holding the primaries were also named, which are much the same as heretofore, except that Campbell, Ritts & Co.'s, and Blocher's were dropped from the list.

After the transaction of some other matters the committee adjourned to meet at the call of the chairman. The meeting was largely attended, each township being represented, and its deliberations were harmonious.

Elk county in the Republican column! Preposterous! But that's the size of it just the same, for the first time in its history.

It was Chairman Wright who conceded Pennsylvania to the Republicans by 20,000. The voters of the State obligingly tacked on the other 163,000.

Grow's majority in the State, when they quit figuring, was 183,851. The official returns from one or two counties were not in at last reports, but they will likely increase rather than diminish these figures.

It used to be that Forest was the only Republican county in this (28th) Congressional district. Now, Clarion is the only Democratic county in it, the others having all rolled up majorities for the Republican ticket at the recent election: Elk 147, Clearfield 1132, Centre 504, while Clarion gave only 172 majority for Hancock.

Had there been a Congressman to elect at this time the Republican nominee would have had 1,989 majority, according to the returns. But wait till next fall.

The Effects are Far Reaching.

At a meeting of the Pittsburg Coal Exchange a few days ago resolutions were adopted earnestly protesting against the meddling with the sugar industry of Louisiana, as contemplated by the Wilson bill. One naturally wonders why the coal men or any other Pittsburg industry should be interested in southern sugar enterprise, especially when so far removed from this locality.

But the reasons will be more fully comprehended when it is understood that Pittsburg coal operators ship annually to New Orleans about 25,000,000 and 30,000,000 bushels of coal, by far the greater portion of which enters into sugar industry, and until the tariff on sugar is definitely settled they cannot with any degree of certainty expect much from that section, and they don't propose to ship their coal there with no prospect that there will be money to pay for it when it arrives.

And thus it is seen how far reaching the sugar bounty or tariff becomes. And this is not all. The coal shipped to these southern points is transported in flat boats and barges all of which are built on the Allegheny and its tributaries above Pittsburg. In fact we might say wholly within three counties—Forest, Clarion and Jefferson—and with the coal industry crippled, the boat industry receives a corresponding set-

back, and this is already being felt in the low price which boats are now selling for, or the prospective price in the spring.

And yet the Democrats tell us the Wilson bill must pass so that times will get better.

More About the Tariff of '57.

A correspondent writing to the Pittsburg Times corrects some mis-statements and erroneous ideas that have been floating around through Democratic papers of the State of late. He says:

The Post makes a savage attack on Congressman John Dalzell predicted on quotations from the free trade Philadelphia Record and James G. Blaine's "Twenty Years in Congress."

The facts of history amply vindicate Mr Dalzell's interview to which the Record and Post take exception. It is true that Nathaniel P. Banks, who was subsequently identified with the Republican party, was Speaker of the House of Representatives which passed the tariff act of March 3, 1857.

He was, however, a minority Speaker, having been elected on February 2, 1856, after a three months' struggle under an agreement by which the candidate having the highest vote should be declared elected. The vote was Banks 103, Aiken 100, Fuller 6, Campbell 4, Weller 1; not voting, 20.

The house was composed of Democrats, Whigs, Free Soilers, Americans and Republicans; neither the House nor its committee was controlled by the last named party. In fact the party was hardly born, its first national convention having been held on the 22d of February, 1856, in Lafayette Hall, Pittsburg, three weeks after Banks' election.

Banks himself was elected to Congress as a Democratic-free Soiler and native American. The house was in fact controlled by the Democrats and the members of the other parties from the South and the representatives of the importing interests of the Atlantic cities.

The Senate was strongly Democratic and the President, Franklin Pierce, was of that faith and was controlled by Jefferson Davis and his colleagues of the Cabinet, as Mr. Dalzell asserted. The tariff bill was in truth as he says, an administration measure.

Mr. Blaine in his "Twenty Years in Congress," quoted by the Post, says: "The one excuse given for urging the passage of the act of 1857 was that under the tariff of 1846 the revenues had become excessive and the income of the government must be reduced. But it was soon found to be a most expensive mode of reaching that end."

In six months after its passage the country had the panic of 1857, the effect of which continued till the breaking out of the war and the passage of protective legislation. The revenues of the government fell off and its credit sank below par. The bad effects of the tariff of 1846 were not felt when the act of 1857 was passed. They were felt most bitterly in 1847 and 1848 with the result that the Whigs elected their President, Gen. Taylor, who died before any change could be attempted, and the discovery of gold which followed in 1849, and the Crimean war, gave the country a great temporary prosperity which received its quietus by the tariff of 1857.

That act was opposed by all the Republican and Whig members from Pennsylvania and was passed in the house by 124 to 71. Men like Seward, Morrill and Colfax bitterly opposed its passage and predicted the results which actually followed. Mr. Dalzell is as usual right and the Post as usual wrong.
