To the Republican Electors of Pennsylvania: I am directed by the Republican State Committee to announce that the Republicans of Pennsylvania, by their duly chosen representatives, will meet in State Convention at Harrisburg, Pa., on Wednesday, May 23, at 11 o'clock, a. m., for the following purposes to wit:

For the nomination of candidates respectively for Governor, Lieutenant-Governor, two members of Congress from the State at Large, Auditor General, Secretary of Internal Affairs and for the transaction of such other business as may be presented. Attention is called to the date adopted at the State Convention of 1893, providing for the basis of representation as follows:

"Representation in future State Conventions shall be based upon the vote cast at the Presidential or gubernatorial elections immediately preceding, one delegate being allotted to each legislative district for every 2,000 Republican voters and an additional delegate for a fraction exceeding 1,000 votes, each district to have at least one delegate."

GALUSHA A GROW in Congress tried to amend the pension bill so as to make the minimum pension given any pensioner \$12 per month. That is very little, but it is much more than most of them get now. It is a pity that Mr. Grow's amendment did not go through.

PETROLEUM remains unprotected in tariff bill reported in the Senate. The sub-committee was expected to restore the clause in regard to oil, but the oil men are doomed to disappointment. The committee had favors for sugar and other Southern industries, but nothing for Pennsylvania. It might be worse, however. That tariff bill hasn't passed yet.—Franklin News.

THE N. Y. Tribune recalls the Democratic hard times of 1837 and 1857, which our older readers will remember, when it says that "The nation is going over the same old Democratic road toward bankruptcy which it wearily and sadly trod many years ago. Prostration to home industries comes first, then demands for the return of many hundred millions of foreign capital invested or loaned here, then shrinkage of Government revenue and issue of bonds with difficulty, and increase of the public debt and heavier burdens for the people. It is not a road which the people enjoy. The extraordinary uprising in Pennsylvania shows what the people think of it. Nor is it strange if dissatisfaction and indignation sometimes lead men to acts of disorder, as in Massachusetts."

HENRY HALL, the Washington correspondent of the Pittsburgh Times, tells this story: A manufacturer called on Senator Hill to-day in great distress. He said he was a member of the Tariff Reform society, and was manufacturing wire rope. Under the Wilson bill there is but a slight reduction in the tariff on the ingots from which his wares are made, while the rate on the finished product is greatly decreased. Thus he was getting hit both ways. He said that when running he employed 600 men, but now he had only work for a score. "That," said Senator Hill, with cool sarcasm, "is the way the tariff is revised by statesmen actuated by principle alone." There are a great many tariff reformers engaged in manufacturing who have been as hard hit as the gentleman who called on Senator Hill. Led away by the specious reasoning and false promises of the Democratic free traders they cast their lot with the party that is now raiding their industries and they are gasping with fright and quaking with fear.
