Prosperity Awaits Protection.

There are some complaints by the doubting Thomases that the election of McKinley has not transported us back at once to such prosperity as we had in 1891 and 1892, under the McKinley law. That is about as reasonable as to expect roses to bloom out of doors in December because June is coming. Because we know June is coming, we may order rose trees, but we don't expect the roses to bloom until the December snow is gone. While the Wilson-Gorman bill is the law of the land we cannot expect any great measure of prosperity. The most that we can hope for is that we may be spared from further disaster. Merchants have the same inducements to buy abroad that they have had from the beginning of the law. It is true that many mills which were closed have started up, and that many others which would have shut down in case of McKinley's defeat have continued. So much substantial good has come from the mere prospect of protection in the future. But these mills have gone on with work in expectation of future orders, when protection to American industries will once more be established, rather than to meet present demands. Confidence has been restored and further disaster prevented by the assurance of the re-establishment of the American system; but real widespread prosperity cannot come until protection to American industries is a reality of the present and not a promise of the future.
