RECENT DEATHS.

WILLIAM THOMSON

Wm. Thomson, whose death occured on Tuesday night, March 1, 1898, was the eldest son of John and Jennette Thomon, of Stewarts Run, this commerty, and was born Dec. 7, 1851. He came to Tio nesta about 4 years ago from Nobraska, Pa., where he had been in the employ of Collins, Kreitler & Co. for a number of years. He was a man of strict integrity, honorable and upright in all his business, and was highly respected by all who knew him. For some time Mr. Thomson's health had been failing, but the end was sudden. An attack of cold or la grippe contracted about ten days prior to treatment, until three days before his

lungs were seriously affected, and that his end was near. He expressed himself as ready to go, realizing that nearness of the Saylour that takes away the sting of death and robs the grave of its victory.




