#### Change River's Course.

New Castle, Pa., Feb. 16 .- The Pennsylvania Railroad company has begun the gigantic undertaking of changing the course of the Mahoning river near Carbon, six miles west of this city, in order to eliminate a long curve. Near Carbon the cut will be nearly half a mile in length, and the public road on the other side of the Mahoning will also have to be changed. Other cuts will also be made between here and Youngstown in the line with the general improvement of transportation facilities.
