ELECTION. **ELECTION.** Whereas, In and by the act of the Gen-eral Assembly of the Commonwealth of Pennsylvania, entitled "An Act to amend the tenth section of an act, entitled 'An Act to regulate the nomination and elec-tion of public officers, requiring certain expenses incident thereto to be paid by the several counties and punishing cer-tain officenses in regard to such elections," approved the 28th day of June, A. D., 1886, it is made the duties of the Sheriff of every county within this Common-wealth to give public notice of the Gen-eral Elections, and in such to— I. and give a list of all the nominations made as provided in this act, and to be made as provided in this act, and to be voted for in such county, and the full text of all constitutional amendments submitted to a vote of the people, but the proclamations posted in each elec-tion district need not contain the names of any candidates but those to be voted for in such district.

He shall give notice that every person, excepting Justices of the Peace, who shall hold any office or appointment or profit or trust under the government of the United States, or of this State, or of any city, or incorporated district, whether a commissioned officer or other-wise, a subordinate officer or agent who is or shall be employed under the legis-Is or shall be employed under the regis-lative, executive or judiciary depart-ments of this State, or of the United States, or of any city, or incorporated district, and also that every member of Congress and of the State Legislature, and of the select or common council of any city, or commissioners of any incor-porated district, is by law incapable of holding or exercising at the same time the office or appointment of judge, in-spector or clerk of any election of this Commonwealth, and that no inspector, judge or other officer of any such elec-tion shall be eligible to any office to be then voted for, except that of an election officer. First-He shall have been a citizen of First-He shall have been a citizen of the United States at least one month. Second-He shall have resided in the State one year, (or, if having previously been a qualified elector or mative born citizen of the State he shall have removed therefrom and returned, then six months.) immediately preceding the elec-


Third-He shall have resided in the election district where he offers to vote at least two months immediately procedng the election

Fourth-If twenty-two years of age or upwards, he shall have paid within two cears a State or county tax which shall have been assessed at least two months and paid at least one month before elec-

tion. Sec. 2. The general election shall be heid annually on the Tuesday next fol-lowing the first Monday of November, but the General Assembly may, by law, fix a different day, two-thirds of all the members of each house consenting there-

10. Notice is hereby given. That any per-son excepting Justices of the Peace who shall hold any office or appointment of profit or trust under the United States. or this State, or any city or incorporated district whether commissioned officer or otherwise, a subordinate officer or agent who is or shall be employed under the legislative, executive or judiciary depart-ment of this State, or in any city, or of any incorporated district, and also that every member of Congress and of the State Legislature, or of the select or common council of any city, or commis-sioners of any incorporated district, is by law incapable of holding or exercising at the time, the office or appoint-ment of judge, inspector or clerk of any election in this Commonwealth, and that no inspector, judge or other officer of such election shall be eligible to be then voted for.

The Judges of the aforesaid districts shall representatively take charge of the certificates of return of the election of their respective districts, and produce them at the Prothonotary's office in the Berough of Tionesta, as follows: "All judges living within twelve miles of the Prothonotary's office, or within twenty-four miles if their residence be in a four miles if their residence be in a town, village, or city upon the line of a railroad leading to the county seat, shall before 2 o'clock p. m., on WEDNESDAY, November Sth, 1905, and all other judges, shall, before 12 o'clock m., on THURS-DAY. 


