Extra Session of the Legislature.

Human nature is the same the world over. When a boy has received a good drubbing he wants to be good right away and to do things meet for repentance. Hardly had the smoke of conflict cleared away last week, revealing a most decided threshing for the Republican party of Pennsylvania at the late election, when Governor Pennypacker issues a proclamation calling the legislature in extraordinary session for the purpose, as he sets forth in his call, of righting some wrongs that were perpetrated at the last session and performing some things that were left undone, supposed to be in the nature of reforms. The session is to conyene on the 15th of January next, and what it will bring forth is too much of a puzzle for the average mind to even guess at, but that it will not the members an average of \$700.00 to \$800.00 per head is a dead sure thing, and foot up a total expense account to the State of about half a million dollars. Following are the lines along which the Governor thinks there ought to be some legislating done, and he seems to think these are so urgent as to warrant this enormous outlay, and we suppose provide a sort of diversion for the languid legislators:

Je Je Ki Ki Ti

First-For the consolidation of Pittsburg and Allegheny into a greater Pittsburg.

Second-To increase the interest payments on state deposits; to limit the amount of deposits in each bank; to make it a misdemeanor to pay or receive, to offer or request any money or valuable thing or promise for the use of such matter right, but the acceptance of her to the state, and to adopt such other measures as may be necessary for the protection of the public moneys.

Third-To reapportion the senatorial and representative districts of the state.

Fourth-To provide for the personal registration of voters. Fifth-To provide for the government

of cities of the first class, and the proper distribution of the power exercised by such municipalities

Sixth-To fix the amount to be expended each year for county bridges, and to take such other measures in regard to them as safety may require.

Seventh-To abolish fees of the Secretary of the Commonwealth and the Insurance Commissioner.

THE cost of the extra session of the Legislature enters largely into all discussions of the Governor's proclamation. Each of the 254 members will receive \$500 as compensation. Then the machinery of the Legislature must be paid for, which usually provides for a general raid on the State's finances. All told the State will be obliged to disgorge about half a million dollars. 
