Very few facts regarding the accidental death of the young man have developed since the first news of the fatality was known.

The body was so badly disfigured that it appeared to be that of a man at least 30 years of age and the publication of that as his name misled his relatives.

On Saturday morning, Mrs. Kahle, the step-mother of the deceased, read in the Derrick that a cigar case marked with the monogram "W. K." had been found in the clothing and the fact that the youth had not been home since Thursday aroused her fears.

Mr. Kahle has learned that Wayne desired to go to Franklin to see the operation of a horseclipping machine by means of a gas engine.

He requested Roland Bailey to go with him on Thursday afternoon, but Roland refused.

Wayne worked about the yard pruning vines and cleaning up the lawn until supper time and in the evening met Bailey, but did not say anything about going to Franklin.

This was about 8 o'clock in the evening and the last an Oil City friend saw him alive.

On Friday morning when he did not come to breakfast his father supposed that he had gone fishing and did not become alarmed until late that night.

He then telephoned to friends and neighbors, but could find no trace of the whereabouts of his son.

When Wayne left Oil City he had about \$10 in his pockets, but when the body was found no money was found in his possession.

The deceased was born at Fern, Pa., July 28, 1886, and besides his father is survived by two sisters, Claribel and Carmen.

Mr. Henry, of this place, uncle of the unfortunate boy, accompanied by Mrs. Henry and daughter Clara, attended the funeral, which was held Monday afternoon.

COLVILLE, WASH., April 29, 1906. EDITOR REPUBLICAN:—I have got my house built and am now living on my claim.

There has been very little rain here for the month of April, but notwithstanding this fact the ground keeps moist and everything seems to be doing well.

The soil is deep and soaks up all the rain that comes, so none runs away into the streams.

The weather through the day is nice and warm but the nights are cold, being sometimes nearly freezing in the mornings.

Everything sells by weight, the bushel measure being nearly unknown. I will quote some prices: Oats \$1.75 per cwt.

What \$1.00 per cwt.; potatoes 65 cents per cwt. Groceries of all kinds are a shade higher here than in the east.

The mills through this county are running steadily and work is plenty. The wages for common labor is about \$2.00 per day.

I would not advise friends to come here for homesteads unless they want to live in the wilderness.

No one is safe in leaving his claim for any length of time, because some one is likely to take possession while they are gone.

The Late E. E. Vockroth.

Ernest Edward Vockroth was born in Rahra, Province of Hesse Cassel, Germany, April 23, 1834, and died in the hospital at Oil City, April 27, 1906.

Four weeks ago he was taken sick and his condition rapidly became serious.

In the hope of ultimate recovery he was taken to the Oil City hospital and underwent an operation, which at first promised to be successful.

but on last Wednesday afternoon he suffered a relapse and continued to grow weaker until death brought release from his sufferings.

In September, 1854, he left the home of his boyhood and came to America, locating in Tionesta.

A year later he removed to Kansas, but only remained there for about a year, when he returned to this place and purchased the farm on German Hill where he resided through the remainder of his life.

He was a carpenter by trade and many of the edifices in this vicinity are substantial monuments to his skill as a master workman.

In April, 1859, he was united in marriage to Martha Elizabeth Ravendorf, who was a schoolmate of his in their home village.

For almost half a century they journeyed together, sharing the privation and toil of their early married life.

Besides his widow, Mr. Vockroth is survived by seven children: Christine and Albert, who reside at home, Mrs. A. F. Ledebur, of Tionesta, Edward, of Milwaukee, Wisconsin, Mrs. E. E. Youngk, of Wilkingsburg, Pa., Mrs. E. S. Blum, of German Hill, and George, of Erie, Pa.

Two sons, Martin and John, died a few years ago.

Mr. Vockroth was one of the successful and substantial citizens of this community.

He filled a number of public offices in the township with great acceptability, and was recognized by all who knew him as a man of honor and honesty.

At the organization of the Citizens National Bank, of Tionesta, he was elected one of the directors and held the position at his death.

In his youth he united with the German Reformed church, but after coming to this vicinity he united with the Evangelical church, and remained a faithful Christian until he heard the voice of the Master calling him home.

In his death the community, as well as the family, have suffered a loss which will be keenly felt, but our loss is his gain.

A large concourse of friends and neighbors gathered at his late home Monday at 9 a. m. and accompanied the remains to the Zuendel church, where appropriate services were conducted by Revs. W. O. Calhoun and E. D. Mowrey.

Letter to C. A. Lanson.

DEAR SIR:—You understand grinding wheat, buckwheat, rye, oats and corn.

We understand grinding white lead and white-zinc. The two sorts of grinding are not much alike.

Very likely oats and wheat behave very differently in the mill, and you manage them differently.

We know very little about your work; don't need to; we'd rather depend on you.

But we paint your horse and mill, and out-buildings; perhaps you'd be glad to know about grinding paint; for some people mix their paint with a stick in a tub.

We use lead-and-zinc—nothing else. And our zinc is as tough as your oats.

They are both white; when are they thoroughly mixed? Tub-mixers don't know it; but tub-mixed lead-and-zinc is a streak of one alongside of a streak of the other.
