#### Adopted by the Republican County **Committee at Its Meeting** July 26, 1907.

BULES OF THE REPUBLICAN PARTY OF FOR-EST COUNTY.

BULK L

Section 1. All primary elections hereafter held in Forest County under the jurisdiction or control of the Republican party in said county, shall be conducted under and in conformity to the Acts of Assembly of the Commonwealth of Pennsylvania, in relation thereto.

SECTION 2. The party officers herein or hereafter provided to be elected by voters of the party electors shall be elected at the spring primary.

BUER ST.

The general supervision, regulation and direction of the affairs of the Republican party in said county, shall be vested as heretofore in the Republican County Committee, which shall be composed of one member from each election district, who shall be elected by the qualified Republican electors of the several districts annually. RULE III.

Section 1. The Chairman of the retiring County Committee shall call the members of the newly elected committee together within thirty (30) days after their election for the purpose of organization, and shall call the committee to order for the purpose promptly at the hour of 2:00 o'clock on the day designated.






