FORREST R. NICHOLS, secretary to W. H. Andrews, territorial delegate to Congress from New Mexico, was found not guilty in the United States District Court in Pittsburgh last week, on the charge of aiding and abetting Cashier T. Lee Clark, who succeeded in wrecking the Enterprise Bank of Allegheny, about two years ago. The case was the last of many growing out of the sensational failure. A majority of the others implicated were convicted. Mr. Nichols is quite well known in the western portion of the state, his former home being Conestoga, and he was a member of the Pennsylvania legislature from Crawford county 20 years ago.

AMONG the most noteworthy victories won at the election last week was the turning over of old Kentucky to the Republican side. The election of a Republican Governor, and the probable capture of the legislature, will be far-reaching in their results, and the Democrats of that rook riddled bourbon state are rattled as they never have been before. It is probable the much honored Calhoun Powers will now get his just dues, and in a short time be a free man again. The persistence with which Democratic authorities in Kentucky have been pursuing this man in their efforts to take his life's blood has shocked the nation for the past eight years, and if the election results in no other good than his freedom from further persecution the victory will still be a cause for honest rejoicing.

The luck of oil well shooters is proverbial, but an accident occurred this morning that puts in the clear any similar affair of the kind that ever occurred in this neighborhood. Herbert Stroud, a shooter employed by the Clarendon Turpedo Company, this morning drove to the magazine, situated some distance from Clarendon, and put on two cans of glycerine and a box of dynamite. The horses then took fright and ran away. The glycerine was thrown out and a hole broken in one can, the top was knocked off another, and both cans became empty by the contents leaking out on the ground. The dynamite also was thrown out of the wagon and none of these exploded.—Warren Times.

A gruesome discovery was made near Clymer N. Y., late Tuesday afternoon, Nov. 5th, by Myron Maxwell, who was hunting and passed through Brownell's woods, where he came upon the skeleton of a man. So horrified was Maxwell when he made the discovery he hastened back to town without making an investigation. He notified Undertaker Damon, who went with the Coroner and others to the woods and removed the bones to Clarysville. With the exception of a signet ring and a badge bearing the number of a Pittsburgh lodge of the A. O. U. W. there was nothing to furnish a clue as to the identity of the man. Several papers lay near the body, but they were so badly crumpled that nothing could be made out. A jack knife and two cents were also found. It is thought the man died two or three years ago, but the Coroner will make an effort to locate relatives by the aid of the lodge pin. The body lay face downward and was partially covered with moss.

David Bish, who is lodged in the Armstrong county jail charged with the killing of Newton Reiddinger, aged 17, at Oak Ridge Hollow on night, stoutly denies that he did the shooting, and his family and quite a number of friends are doing everything in their power to get him clear of the scrape. At the inquest the coroner's jury came to a verdict that the dead man had come to his death by being shot with a gun in the hands of David Bish and this together with the fact that he was once before jailed on the charge of beating his wife, goes pretty strongly against him. A number of witnesses at the inquest swore positively that Bish had fired the fatal shot. The funeral of the dead boy was held last Sunday and it was one of the most largely attended ever held in New Bethlehem.—Kittanning News. The victim of the shooting was a nephew of the late Jacob Swartz, Pinosok, near Oil City.
