## Guilty as Indicted.

The trial of H. H. Baumgardner, one of the Venango County Commissioners, for miscemeaner in office, occupied the time of the Court in Franklin the first three days of last week, and resulted in the jury bringing in a sealed verdict Wednesday evening. Thursday morning at 9:00 o'clock the verdict was opened and proved to be "guilty as indicted." The attorneys at once asked for the usual ten days time in which to file reasons for a new trial. If a new trial should be refused by the Court the case will in all probability be appealed to the Superior Court in Pittsburg.




