

Constitutional Amendments Carried.

A Harrisburg dispatch states that complete official returns from sixty-four counties of the state and telephonic reports from official sources from the remainder show that the schedule for the enforcement of the constitutional amendments was ratified at the recent election by the small majority of 1028. The returns of Allegheny, which were telephoned to the capitol, showed a majority of 5,514 for the schedule which overcame Socialist candidate, had 22,320 votes in the adverse majority of 4,486 in the rest of the State. the state.

State officials say that there is no doubt about the ratification of the amendments except number 7. The first amendment has an apparent majority in the state of 17,197. The amendments which have been written into the Constitution have for their main purpose the abolishing of the February election. The last February election will be held in 1910. After that the past five weeks picking grapes. all district, ward, borough, city and county officers and district judges will be picking apples at Mrs. Maze's, Thursday, chosen on the Tuesday next following the first Monday of November in the oddnumbered years. Judges of the Supreme and Superior Court may be elected at the Mrs. Norton, at Leeper, Thursday. municipal election, if circumstances require. On the same day in November in the even-numbered years, all state officers are to be elected.

The first election under the amended telville. constitution will be held in November, 1910. Then a Governor, Lieutenant Governor, Secretary of Internal Affairs, Hottelville. 32 Congressmen, 25 State Senators and 207 members of the house of Representatives will be elected. In the even-numbered years, the election will be known as the "general election" and in the oddnumbered years as the "municipal election." Special elections can be ordered where it is necessary to fill an unexpired term of either a state, county or municipal officer.


