SEATED LANDS.

BY VIRTUE of an Act of Assembly entitled "An Act to regulate the collection of taxes on unseated lands," approved the 6th day of June, 1887, interest will be charged on 1908 taxes from January 1, 1909, to date of payment, and on 1909 taxes from January 1, 1910, to date of payment, at the rate of six per cent, per annum. Five per cent, will be added on all taxes on seated lands.
